## **GENERAL INFORMATION**

This survey is conducted under the authority of the *Statistics Act*, Revised Statuce of Canada, 1985, Chapter S-19. COMPLETION OF THIS QUESTIONNAIRE IS A <u>LEGAL RECUREMENT</u> UNDER THIS ACT.

#### Purpose of this survey

This survey collects the data needed to produce statistics on the annual volume and value of wool purchases from Canadian farmers. These data will be aggregated with data from other sources to produce national and provincial estimates. These estimates are used by government and the private sector of make policy and investment decisions.

#### Confidentiality

#### Your answers are confidential.

Statistics Canada is prohibited by law from releving any information it collects which could identify any person, business, or organization, unless consent has been given by the respondent or as permitted by the Catalistics Act. The confidentiality provisions of the Statistics Act are not affected by either the Access to Information Act or any other legislation. Therefore, for example, the Canada Revenue Agency cannot access identifiable survey records from Statistics Canada.

Information from this survey will be used for statistical purposes only and will be published in aggregate form only.

#### Record linkages

To enhance the data from this survey, Statistics Canada may combine it with information from other surveys or from administrative sources.

## **Data-sharing agreements**

To avoid duplication of enquiry, Statistics Canada has entered into data-sharing agreements with provincial statistical agencies, which must keep the data confidential and use them only for statistical purposes. Statistics Canada will only share data from this survey with those organizations that have demonstrated a requirement to use the data.

**Section 11** of the Statistics Act provides for the sharing of information with provincial statistical agencies that meet certain conditions. These agencies must have the legislative authority to collect the same information, on a mandatory basis, and

the least tion must provide substantially the same provisions for confidentiality and penalties for disclosure of confidential intermation as the *Statistics Act*. Because these agencies have the legal authority to compel businesses to provide the same information, consent is not requested and operations may not object to the sharing of their data.

For this survey, there are **Section 11** agreements with the provincial statistical agencies of New Brunswick, Quebec, Ontario and Alberta.

The shared data will be limited to information pertaining to operations located within the jurisdiction of the respective province.
