You also know better than anyone that the agriculture industry is subject to many uncontrollable changes: fluctuations in weather, input prices, transportation costs and crop prices, to name a few. We recognize that timely information is important for you to make the best decisions possible.

Five surveys equal in-depth information

Statistics Canada conducts the *Farm Surveys* in March, June, July, November and December to produce the **Field Crop Reporting Series**. Information from these surveys provide Canadians and Canadian farmers with important field crop statistics, including seeded and harvested areas, yields, production and stocks.

The **Field Crop Reporting Series** helps

- track major grain production nationally and provincially, aiding supply management in a timely manner;
- determine the availability of crops by stock assessments as of March 31st, July 31st and December 31st;
- provide annual trend information by crop and small area regions, which can be incorporated into future crop planning.

Who uses the data?

Various partners, associations and stakeholders, ranging from universities to government agencies use the data to formulate policies and programs that assist the agricultural sector. The data help provide an overview of the crop landscape and farming economy in Canada.

Did you know?

- The Fair Rail for Grain Farmers Act, Bill C-30, was supported by information farmers provided on the field crop surveys of 2013 and 2014.
- Canola is the second largest crop grown in Canada, after wheat. In 2015, 18.4 million metric tonnes were produced.
- Soybean production in Canada doubled between 2005 and 2015, to 6.2 million metric tonnes. Farmers in Ontario, Manitoba and Québec produced 94% of the national total in 2015.
- Area seeded to lentils in Saskatchewan and Alberta reached record levels in 2015 and 2016.
- In British Columbia and in the Maritimes, tame hay typically accounts for over half of the total field crop area reported.
